### ASSIGNMENT/CONSENT TO PUBLISH

The National Council of Teachers of English (“NCTE”) is pleased to undertake the publication of your contribution entitled: \_\_\_\_\_ (the “Contribution”) to be included in *English Journal*, as edited by Toby Emert and R. Joseph Rodriguez, Coeditors.

As a condition of publication, NCTE requires that you grant us all rights, including all rights in the copyright, in the Contribution.

**APPROVAL AND ACCEPTANCE:** We mutually agree that publication of the Contribution is contingent upon its express acceptance for publication by NCTE and upon its meeting NCTE editorial standards and other specifications in NCTE’s wholly independent discretion. This Agreement does not create an independent obligation for NCTE to publish the Contribution.

**COPYRIGHT ASSIGNMENT:** Whereas NCTE undertakes to publish the Contribution as above, and whereas you desire to have the contribution so published, now, therefore, you grant and assign to NCTE for its exclusive use the entire copyright in and to the Contribution. The copyright consists of any and all rights of whatever kind of nature now or hereafter protected by the copyright laws of the United States and of all foreign countries in all forms of communication, and NCTE shall be the sole owner thereof.

NCTE, in turn, grants you the limited right to republish the Contribution in any scholarly work, subject to your obligation to notify NCTE of your intent to do so and subject to the inclusion of proper credit in the work to the original publication of the Contribution by NCTE.

**WARRANTY:** You warrant that the Contribution is original to you; that it contains no matter which is libelous or is otherwise unlawful or which invades individual privacy or infringes any proprietary right or any statutory copyright; and you agree to defend, indemnify and hold NCTE harmless against any claim or judgment to the contrary. Further, you warrant that you have the right to assign the copyright to NCTE, and that no right protected by copyright to the Contribution has been previously assigned. It is understood that the copyright to the Contribution has not been registered with the U.S. Copyright Office, but in the event that U.S. Copyright Office registration has taken place, you will promptly transfer the issued copyright to NCTE.

**PREVIOUS PUBLICATION AND PERMISSION:** You warrant that the Contribution has not been published elsewhere, in whole or in part, and that no agreement to publish the Contribution, or any part or version thereof, is outstanding. Should the Contribution contain any material which requires written permission for inclusion in the Contribution, such permission shall be obtained at your own expense from the copyright owner and submitted for review by NCTE at the time of submission of the manuscript to NCTE.

**REQUESTS TO REPRINT:** As owner of the copyright to the Contribution, NCTE has the sole authority to grant a request to reprint and distribute the Contribution, or any parts thereof, except in the situations described below in Author Uses. However, pursuant to the NCTE Copyright and Permission Policy then in effect, NCTE may attempt to obtain your approval should NCTE receive a request to reprint all or any portion of the Contribution for commercial use. This attempt shall include a notice directed to you using your last known email address outlining the use, the proposed fee, if any, and allowing 30 days for a response. Failure to respond in the stated time period will be deemed to constitute consent. Fees will be handled according to the NCTE Copyright and Permission Policy then in effect.

AUTHOR USES: NCTE agrees that you may

- (1) make copies of the Contribution available to your students in print and/or digital form;
- (2) provide electronic copies of the Contribution to colleagues for professional use;
- (3) post the official final version of the Contribution (post-publication) in an online, restricted-access, institutional repository or other Internet venue as long as it is not part of a commercial venture and grants proper credit to the original publication.

However, nothing in this section is intended to transfer rights granted to NCTE under this Agreement.

**COMPENSATION: You shall receive no royalty or other form of compensation in exchange for this assignment of rights.**

**RELEASE:** In exchange for information and services provided to you and in connection with your participation with NCTE, and for other good and valuable consideration, you agree to release, forever discharge, and hold harmless NCTE, its officers, agents and related companies, of and from any and all manner of claims, actions, causes of actions, demands, obligations, liens, rights, damages, costs, loss of service, expenses and/or compensation of any nature whatsoever arising from the use of work created submitted by you to NCTE for inclusion in any NCTE related publication or website.
